The subject is situated on Dargan Road adjacent to Duncrue Industrial Estate, an area of mixed use approximately 3.6 miles north of Belfast City Centre.

The Duncrue area is considered one of Northern Ireland's leading destinations for warehousing and distribution facilities, with superb links to the M1 & M2 infrastructure. Belfast Harbour and ferry terminals are located a short distance away off Dargan Road.

#### **Description**

The site is undeveloped and grass covered.

Access to the site is provided off Dargan Road.

0.73 acres / 2954 sq m




